<p><b>Faculty Council-</b> Faculty Council is formed by the election of 5 members: Each of the academic divisions shall elect a division member to serve as its representative on the Council; the Chairperson of the Faculty is elected by the full faculty. No faculty member may serve for more than two consecutive terms—four years. After two years off the Council, a former representative may be re-elected as a Council member. <p><b>Promotion and Tenure</b> Terms are for two years beginning the fall semester following the spring election. Election of division committee members and the at-large member occur every other year, on an alternating basis, as terms expire for each. In odd years, the full faculty will elect the at-large member and the Fine Arts and Science Divisions will elect their members; and in even years the Humanities and Social Science Divisions will elect their members.
